## ON THIS DAY IN WEST VIRGINIA HISTORY February 2



On the evening of February 2, 1864, Confederate troops under Major James H. Nounnan launched a raid that resulted in the capture of Union General E. P. Scammon and the steamer *B. C. Levi* at Red House early on the following morning.

- 6. What historical questions can you answer using this source? What are the benefits of using primary sources?



**Think Critically:** Imagine yourself as President Lincoln in late June 1863. The war had not gone according to plan. Defeat is becoming a legitimate possibility. Write a passage (*3-5 sentences*) in your "journal" about your mindset. Are you prepared to fight until the bitter end? Are you prepared for the possibility of negotiations with the Confederacy and the prospect of a permanent split of the Union?

• What would have happened if the South had won the war? Would slavery have continued? How did the Union's goals change during the war? What lasting impact(s) has the Civil War left behind?

### **GEN. ELIAKIM P. SCAMMON**

Letter about creating a union secret service in the Kanawha Ft. Scammon (Fayetteville) and Charleston (Fort Hill) named for him

Bead Quarters 3rd Division, 8th Army Corps, Charleston, Na., May 24, 1813. To His Excellency The gorer wor of Virginia ! Some time ago the following place for obtaining swift and accurate information form our front was discufed by the adjutant General of Virgunia (in your absence) and one of my staff: The forer un of Virginia to select not exceeding three citizen of known and approved loyalt from each of the border conneties, to a simployed in the secret service of the Government; whose dut it shall be to report instant, to the nearest military commander of 21. 3, forces all more went of the eveny on our front, and all information of whatever Kind which may be valuable to the wilitary services - such person to be haid a stated compensation out of appropriate Quarter Master Junds of the array. The persons suployed to follow ostensibly their or: dinany avocations, and to be, in the fullest sense of the term, secret service men.
