

TO J. W. BLAKELY, TRADING AND DOING BUSINESS AS POCAHONTAS THEATRE, WELCH, WEST VIRGINIA:

You are hereby notified that the undersigned, RKO Distributing Corporation, a corporation, will move the Circuit Court of McDowell County, West Virginia, on the first day of the March, 1931, term thereof, for a judgment against you for the sum of \$1099.61 and the costs of said motion; which said motion is based upon certain contracts entered into between you and the plaintiff, dated the 3rd day of February, 1930, for the exhibition of certain motion picture productions; that you refused to receive and exhibit certain of the motion pictures referred to in said contracts, a more particular list of which said motion pictures so refused by you is set forth in Schedule "A" attached hereto and made a part of this motion for judgment. That by reason of your failure to receive and exhibit the said pictures you became liable unto the plaintiff company under the said contracts for the respective amounts set forth opposite each picture listed in said Schedule "A"; that the total of the said amount due by you to the plaintiff as set forth in said Schedule "A" is \$1065.00, which said amount bears interest from the 24th day of August, 1930, which said date is the last date that the plaintiff could furnish to you any of the pictures so refused by you and set forth under the said Schedule "A", which said interest amounts to \$34.61, and that there is now due and owing to the plaintiff from you the sum of \$1099.61. That the original copies of the said contracts will be produced in open court at the trial of this motion.

At which time and place you may attend and show cause against such motion, if any you can.
